# Description

FloorGuard rolls are made of High Density Polyethylene (HDPE) in a dimple pattern that offers a strong resistance to hydrostatic pressure and excellent drainage. FloorGurad creates a space for water to flow to an interior basement water collection system.

The dimples are aligned along a vertical and horizontal axis to rapidly channel water that penetrates into a basement to the underslab interior water collection system.

FloorGuard products are considered "Green" products due to their recycled content used as raw materials.

#### Use

Use FloorGuard to channel water that leaks into a basement at the cove joint, through concrete block, cracks, or penetrations. FloorGuard creates a space for water to flow over the footing and under the slab. This water is then collected by the underslab water collection system and drained or pumped away from the building.
